### Social

Shall be those persons who have attained the age of eighteen (18) years of age and who satisfy the Board that they are interested in the objects of the Club but who are not qualified for admission as Active members or Associate members, may be elected by the Board to Social membership of the Club.

### **Senior Active**

Shall be those persons over the age of eighteen (18) years who are actively engaged in the sport of rowing or the administration thereof and who are elected by the Board to Senior Active membership of the Club.

# Senior Active Non-competitive

Shall be those persons who have attained the age of eighteen (18) years who are actively engaged in the sport of rowing or the administration thereof but who do not compete in regattas and who are elected by the Board to Senior Active Non-competitive membership of the Club.

# Junior Active

Shall be those persons who have not yet attained the age of eighteen (18) years but who are actively engaged in the sport of rowing on a regular basis and from whose parent or guardian the Board receive written consent to that person becoming a Junior Active member of the Club and taking part in the sporting activities of the Club and who, in the opinion of the Board is suitable to be admitted to Junior Active membership of the Club.

### Associate

Shall be those persons who have attained the age of eighteen (18) years and who have completed not less than two (2) years Competitive Active membership with a rowing club; or who have satisfied the Board as to their record of administration in the sport of rowing in a school or other rowing club and who are elected by the Board to Associate membership of the Club.
